The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapter 707 of the Nevada Administrative Code. These regulations are being proposed pursuant to Senate Bill 268 which was passed in the 2013 Legislative Session, providing a mechanism for providers of wireless telecommunications services in Nevada to submit their emergency contact information to the Department of Public Safety, General Services Division.
