5. **For possible action:** Requested Agenda Item from the July 18, 2017 Hearing – Sex Offender Tier Scoring Procedure. Review of the requested informal audit from the July 18, 2017 Reconsideration Assessment Hearing. At the July 18, 2017 hearing, panel member Connie S. Bisbee requested that the Department of Public Safety conduct an audit on offenders who have been tier assessed as a result of a conviction for Possession of Child Pornography to review the scoring on the Degree of Force, Victim’s Injury, Degree of Contact, and Age of Victim factors. The Department of Public Safety will provide the results of the informal audit.

6. **For possible action:** Review and consideration of applications for reconsideration of community notification tier assessment pursuant to the Nevada Guidelines and Procedures for Community Notification of Adult Sex Offenders. **As to each individual listed below, the Panel will:**

b. Deliberate on the individual’s application for reconsideration pursuant to the Nevada Guidelines and Procedures for Community Notification of Adult Sex Offenders §6.00 and §6.10; and

c. Take Action on the request by (1) affirming the tier level assessment; (2) lowering the tier level assessment; **or** (3) increasing the tier level assessment.
