

# **NCJIS Modernization Update**

The Nevada Criminal Justice Information System (NCJIS) Modernization Program is a multiyear effort and a significant transformation that embraces state-of-the-art technology to better serve your business needs.

This modernization effort replaces existing systems and adds critical functionality for internal and external users that will provide improved services to civil businesses while improving the efficiency and effectiveness of public safety operations.

The NCJIS Modernization Program Team is currently focused on these activities:

#### **Criminal Justice Agencies**

- Preparing agencies to operate in the new NCJIS environment
- Testing the new solutions for functionality and operability
- Training criminal justice agencies on the new solutions and processes
- Migrating all criminal justice agencies by assigned groupings to the new NCJIS environment

#### **Civil Businesses**

- Design meetings about the upcoming, online civil business services
- Planning of informational events for civil businesses by business type and location

The Nevada Civil and Criminal Information System (NCCIS) is a new cloud-based web portal for both civil business and criminal justice users. It provides a new way of interfacing with the Nevada Department of Public Safety and is accessible through any web browser. # **Questions and Answers**

Some of the questions that came up during our Civil Change Ambassador meetings are listed below, along with the answers provided by the NCJIS Modernization Team that you may find helpful.

Question	Will firearms dealers (FFLs) be able to submit background checks online?
Answer	Yes, the ability to submit background checks online is a feature of the new system. The background status will also be returned online. The ability to submit a background over the phone will remain available as well. There will be no faxing of submissions once the NCCIS Portal is active for the FFLs.
Question	How are each of the firearm background check statuses going to be handled for online submissions?
Answer	Either a Proceed or Delay status will be returned online as soon as it is determined.
	After a Delay, the status of the background will be updated within the existing three-business-day time frame, and the FFL will receive a notification of a status change.
	Upon a "final" status—Proceed, Unresolved, or Deny—the State and NICS numbers will be provided.
Question	How will an FFL provide the 4473 on a denied background?
Answer	Providing the 4473 on denied backgrounds will still be using the fax at this time. This may change in the future.
Question	Are there any changes to the time frames for backgrounds?
Answer	No, all time frames are set by the FBI and the ATF.
	<ul><li>Delay remains three business days.</li><li>Unresolved continues to be worked on for 90 days.</li></ul>
Question	Are there changes coming for the Civil Applicant Program?
Answer	The process for civil applicant fingerprint submissions via Live Scan machines will remain virtually the same. An option to pre-enroll your applicants will be covered in training.
	The NCCIS Portal will provide the ability for your business to track what stage your applicant is in the process and receive the background check results electronically.
	The ability to mail in fingerprint cards and have hard copies mailed back to your business remains available.

### Change Engagement

The change manager will continue to engage with civil business change ambassadors to provide program updates with key information on planned activities and help your organization prepare for using the new online civil applications through the NCCIS Portal, anticipated to be available by 2024.
