



Phase 2 Update






Software Upgrade Law Enforcement Message Switch (JLink)

- Verified application functionality
- Test environment setup in process
- Project delayed by higher priority projects
- User test sites determined
- User testing planned to begin in May
- Scheduled for completion by end of calendar year 2016



CCH and OTIS

- Project schedules approved for completion by June 30, 2017
- Project broken into functional areas for effective management and use of resources
- For each functional area the team will:
 - Develop functional design in Joint Application Design Sessions
 - Write a Functional Design Document section
 - Write a Technical Requirements Document
 - Develop software
 - Test software—technical and user




CCH


OTIS

Phase 3 Proposed Projects

- 1. NCJIS Modernization Phase 3-Criminal Project
 - Technical oversight for program
 - Provide System Integrator--expertise to "glue" projects and environment together
 - Ensure all **Hot Files** are updated
 - Perform Validation and Verification testing for program
 - Develop Business Continuity Plan for General Services Division
 - Implement new Validations solution
 - Move Temporary Protection Order System (TPO) off USoft
 - Modify JLClient and JLink based on changes to above projects

Phase 3 Proposed Projects

- 2. NCJIS Modernization Phase 3--Civil Project
 - Purchase and implement Enterprise Content
 Management (ECM)
 - Implement a new Civil Requests solution possibly using ECM that would replace all of the following:
 - Provide a public web **Portal** to customers
 - **Civil Applicant** application functionality and add enhancements
 - **Civil Name Check (CNC)** application functionality and add enhancements
 - **Brady** application functionality and add enhancements
 - Carry Concealed Weapons (CCW) functionality and add enhancements
 - Replace Accounting Application (Accounts Receivable) to work with Civil Requests and add functionality
 - Modify JLClient and JLink based on changes to above projects

Phase 3 Proposed Projects

- 3. Switch Support Project
 - Move JLink support to state personnel so that it is more sustainable
- Implement additional enhancements to Phase 2 projects
 - Computerized Criminal History (CCH)
 - Offender Tracking Information System (OTIS)

Phase 3 Planning

- Documenting "as is" process flows
- Documenting "to be" process flows
- Collecting business requirements for "to be" process
- Sending out Requests for Information (RFIs) to vendors of potential solutions
- Reviewing alternative solutions
- Preparing costs for alternative solutions
- Preparing Technology Investment Requests (TIRs)
 - Due April 15
