The hearing concerns regulation amendments relating to concealed firearms and revising the application form for the issuance or renewal of a permit to carry a concealed firearm; also concerning the repeal of regulations governing the collection, maintenance and use of emergency contact information of providers of wireless telecommunications. The purpose of

The following information is provided pursuant to the requirements of Nevada Revised Statute (NRS) 233B.0603:

1. The need and the purpose of the proposed regulation amendment/repeal

RCCD drafted proposed regulation amendments to Nevada Administrative Code (NAC 202) to align the regulations with statute and to eliminate duplication of applications for the issuance or renewal of a permit to carry a concealed firearm.

RCCD proposes to repeal NAC 707.100. The regulation is duplicative of what the statute requires and added a layer of complexity to the Division's responsibilities. Information is not being received in the manner prescribed by regulation. Therefore, the Division has developed and implemented internal policies and procedures for the collection, maintenance and use of emergency contact information.

2. How to obtain the approved or revised text of regulations

3. Methods used in determining the impact on a small business

The Division used informed, reasonable judgment in determining that there would not be an impact on small business due to the nature of the regulation changes to NAC 202 and the repeal of NAC 707.100.

The proposed amendment to NAC 202 makes minor changes to requirements already established and in place by local law enforcement agencies who issue concealed firearms permits.

NAC 707.100 is duplicative of statute. Therefore, the impacted entities will still perform the same duties to provide the Division with emergency contact information pursuant to statute in the absence of the proposed repealed regulation.

4. Estimated economic effect of regulation on businesses and the public

a. Adverse and beneficial effects

The Division finds that the proposed changes to NAC 202 will have no adverse economic effect on small businesses or local law enforcement agencies. The amendments reduce duplicative application requirements, aligns the outdated regulations with current statute and provides for updates to the application in line with state and federal firearms laws.

In reference to the repeal of NAC 707.100, the regulation was duplicative of what the statute requires, therefore there is no adverse effect on businesses and the public.

b. Both immediate and long-term effects

The proposed amendments of NAC 202 and repeal of NAC 707.100 do not present any reasonable, foreseeable, or anticipated immediate or long-term economic effects on small businesses or the public.

5. Cost for enforcement of the regulations

The proposed amendments of NAC 202 and repeal of NAC 707.100 present no significant foreseeable or anticipated cost.

6. Overlap or duplication of other state or local government agencies

The proposed amendments of NAC 202 do not overlap or duplicate any regulation of other federal, state or local government entities, but does reference regulatory authority granted by NRS 202.

NAC 707.100 – not applicable.

7. Regulation required by federal law

Not applicable.

8. More stringent than federal regulations

The Division is not aware of any similar federal regulations of the same activity in which the state regulations are more stringent for NAC 202 and NAC 707.100.

9. New or increases in existing fees

The proposed amendment to NAC 202 does not include new fees or increase an existing fee.

The repeal of NAC 707.100 is not applicable to new or increased fees.
