This newsletter issue provides high-level information on the upcoming Warrant/Validation Initial Operating Capability (IOC) go-live, still anticipated to take place on May 7, 2024. The newsletter includes relevant information regarding the preparation, training, and go-live migration of warrant entry agencies.

NCJIS Modernization Program

In 2019, the Nevada Legislature funded the six-year NCJIS Modernization Program to modernize NCJIS services. The program consists of three phases that were outlined in our previous Criminal Justice Newsletter, Issue 15. **Phase 1** was completed in May 2023.

Currently, **Phase 2** is well underway with the preparation, training, and go-live of warrant entry agencies (as inquiry only) to eAgent through the new Law Enforcement Message Switch (LEMS). **Until such time that the new Warrant System Initial Operating Capability (IOC) is cut over to production, all entry agencies will continue to perform National Crime Information Center (NCIC) entry using JLink, but agencies can use eAgent for Inquiry functions.**

More information on preparation and training is provided in the sections below.

In late 2024, **Phase 3** will provide new automated capabilities to Nevada's civil businesses. This deployment will create efficiencies and provide a faster, more efficient way to perform Point-of-Contact Firearms background checks and both fingerprint- and non-fingerprint-based background checks required by law.

The NCJIS Modernization is still on schedule to replace the State's Computerized Criminal History (CCH) system—the central repository for Nevada criminal history records. This enhanced system expands and improves the efficiency of the State's processes.

Hand-in-hand with this CCH update will be the rollout of a new Disposition of Firearms (DOF) background check capability to law enforcement agencies, which will provide functionality to process a National Instant Criminal Background Check

Warrant/Validation IOC Go-Live

As mentioned above, the Warrant and Validation systems' IOC go-live is still anticipated to take place on May 7, 2024.

Stage 1 is wrapping up with preparation, training, and agency migration for the ability to query records. Most warrant entry agencies have been migrated to LEMS/eAgent.

In **Stage 2**, agencies will receive training before the Warrant/Validation IOC, enabling them to start entering and validating records in eAgent. *Information on these regionally located training sessions is provided in the section below.*

The NCJIS Modernization Team is currently engaged in User Acceptance Testing (UAT), occurring from March 14 through April 29, 2024. Selected testing agencies have already been contacted.

Warrant Entry Agencies, Stage 2 – Entry Using eAgent to LEMS

After Warrant/Validation IOC, entry agencies will have the capability to enter warrants into the new system. The steps for the future Warrant/Validation IOC are as follows:


- Confirmation will be received from the Unisys vendor exactly when the IOC will take place.
- This will initiate preparation tasks for the NCJIS Modernization Team to carry out.
- The data migration will be scheduled. Agencies will be notified in advance of the migration process, including the specific dates and what they should expect.
- The warrant database will be placed in a query mode until warrant data is migrated and verified.
- Agencies will be notified when the system is live and that they can initiate warrant entry and validations using eAgent.


Agency Training Information

The NCJIS Modernization Team is holding in-person warrant entry training. These in-person sessions will not have the ability to join via Microsoft Teams.

The Records, Communication and Compliance Division's **NCJIS Compliance Unit** (**NCU**) will soon schedule online warrant entry training sessions via Microsoft Teams. These dates are yet to be determined.
