



# Warrant Entry and Validations Go-Live



## Warrant Entry and Validations Go-Live Update

- The Warrant Entry and Validations Go-live target date of July 15, 2024, will not take place.
- The new Warrant Entry and Validations Go-live date is September 9, 2024.
- Agencies will continue to validate National Crime Information Center (NCIC) records in the current JLink system until August 31, 2024.
- After the Warrant Initial Operating Capability (IOC) go-live, and going forward, agencies will complete validations through the Nevada Civil and Criminal Information System (NCCIS) Portal using the CJIS Validation Application provided by the vendor Peak Performance.



### Warrant Entry and Validations

#### **Go-Live Key Points**

- Warrant entry will be frozen from September 5 at 23:00 to September 9 at 06:00 for database migration.
- NCIC Warrant Entry Plan A plan is in place for NCIC warrant entry, clears, and locates via JLink during the freeze. This plan will be for warrants deemed as serious, used minimally, and will be reconciled after go-live. Instructions will be delivered 30 days before go-live.
- Agencies will be notified when they can resume entering warrants in eAgent
   2.0/LEMS following the successful go-live.
- In the unlikely event of a rollback post-go-live, agencies may need to re-enter any manually tracked warrants.



#### Warrant Entry and Validations

#### Go-Live Communication Plan

- The following communications are planned to inform and prepare criminal justice agencies on the upcoming IOC go-live of the new Warrant Entry and Validations solutions on September 9, 2024:
  - August 12, 2024 Detailed information and instructions on the go-live process will be delivered, including details on the timeline, communication plan, support process, and rollback plan.
  - August 19, 2024 Confirmation of the planned Warrant and Validations systems Golive date.
  - August 19–23, 2024 Informational meetings for Change Ambassadors.
  - August 28, 2024 Reminder of the Warrant and eWarrant entry freeze from September 5 23:00 to September 9 12:00 to allow for database migration.
  - **September 4, 2024** Repeated reminder of the Warrant and eWarrant entry freeze from September 5 to September 9, 2024.
  - September 9, 2024 Agencies will receive notification that the new system is live, enabling them to initiate warrant entry and file validations using eAgent.

#### **Agency Preparation**

#### **Training**

- The NCJIS Modernization Team has provided these training sessions:
  - Creating a User in the NCCIS Portal\*
  - eAgent Navigation\*
  - NCJIS and NCIC Warrant Entry
  - Validations
- In-person training sessions were recorded and made available to agencies to access in the NCJIS Modernization Microsoft Teams:
  - > DPS NCJIS Mod Agency Information>Agency Training>Warrant Entry Demonstration and Handouts
- Additional training is being scheduled July and August, closer to the new go-live date of September 9, 2024.
- \*NCJIS Compliance Unit (NCU) is delivering ongoing training.



#### **Agency Preparation**

#### How it Should/Should Not Work – The Ask

- Here is how it should work:
  - 1. NCJIS Mod Team provides training on the new system.
  - Users are given temporary log-in credentials, with reminders delivered to reset their passwords.
  - 3. Users should immediately start using the new system and apply their skills after training.
- Here is how it should not work:
  - 1. Not putting the training information into practice.
  - Training information is lost or forgotten, causing the need for retraining.
  - 3. Users not accessing the NCCIS portal for 90 or more days, resulting in being locked out of the system.
- The Ask: The DPS Modernization Team requests that sheriffs and chiefs support this
  training effort by ensuring users apply the training immediately. This will reduce
  confusion and the need for additional assistance and reduce the strain upon TACs,
  the NCJIS Mod Team, and DPS training personnel.

### Foreign Hosts

- The original goal was to have all impacted agencies complete their new Foreign Host (FH) connection by May 15, 2024.
- The new foreign host migration deadline is **October 15, 2024,** to ensure agencies with FHs are fully functioning before JLink is decommissioned.
- Agencies with the greatest impact are prioritized.
- The agency onboarding process is heavily dependent upon their IT resources and vendors.
- Administrators may wish to ask vendors about their timeline to avoid service disruptions.
- DPS resources are still supporting this effort but are heavily engaged in the following tasks:
  - CCH system
  - DOF solution
  - Civil application testing and deployment
  - User acceptance testing (UAT) for multiple interfaces
  - Training and go-live for criminal justice agencies on new solutions
  - Training and go-live for civil business customers on new solutions



## Helpful Tips and Reminders



#### Helpful Tips and Reminders

#### The following information has been provided to your agency:

- Existing eAgent users may notice changes to the response formats as interfaces are moved off JLink and onto the Law Enforcement Message Switch (LEMS). The main difference is that the fields may be in different locations. Information is not changing.
- Warrant entry agencies should work to add NIC numbers to each NCJIS warrant record if a corresponding NCIC warrant exists.
  - If this process is not completed before the final data migration, it could result in NCJIS warrants being duplicated.
- Agencies may not add the same NIC number to more than one State warrant. A NIC number can only be used on one NCJIS warrant at a time. We recommend adding it to the most egregious warrant.



## Helpful Tips and Reminders Phase 3

- On deck (Scheduled for early 2025)
  - Replace the State's CCH system, the central repository for Nevada criminal history records.
  - Roll out the new DOF background check capability to law enforcement agencies, providing functionality to process a National Instant Criminal Background Check System (NICS) background check when releasing firearms from an agency's evidence vault.
  - Provide new automated capabilities to Nevada's civil businesses. This
    deployment will create efficiencies and provide a faster, more efficient method
    for performing Point of Contact Firearms background checks, as well as both
    fingerprint- and non-fingerprint-based background checks required by law.
