Program Overview



The NCJIS Modernization Program is preparing to roll out training for our criminal justice community on the NCCIS Portal and some criminal justice solutions. The rollout plan for all solutions for use by both criminal justice and civil business is under development. Preferences for training will be sought from our civil stakeholders toward the end of 2022. These and many other considerations are being taken together to ensure the training is as impactful as possible. See the high-level schedule in the section below.

A cloud-based solution, the **NCCIS Portal** provides a new way of interfacing with criminal justice systems and supports more features, capabilities, and reliable access. It is based on an industry standard, NIEM XML.

The NCCIS Portal will enable the public to submit requests and receive results for the background checks they are authorized to perform, including:

- Brady Firearms Check
- Civil Name Check

- Personal Identification Check
 - Civil Applicant Processing
